Subject :- Revised Administrative approval and allocation of fund towards Improvement of Rig Unit 34D/AR/WDS-450 and Rig Unit 47D/AR/LMP under Central Mechanical Division, PHE Directorate under ARWSP during 2009-10.

**ORDER**

The undersigned is directed by order of the Governor to say that the administrative of Improvement of Rig Unit 34D/AR/WDS-450 and Rig Unit 47D/AR/LMP under Central Mechanical Division, PHE Directorate was accorded vide G.O. No. PHE/IV/1956/W-40/07/(Pt-I)/A.O.-47 dated, 28.07.2009 at an estimated cost of Rs.20.47 Lakh under ARWSP during 2009-10 and the entire amount was also released in the same order . Later, it was observed that the actual estimated cost of the project would be Rs. 43.38 Lakh in stead of Rs. 20.47 Lakh and it was mere typographical mistake.

Under the circumstances as stated above, the undersigned is further directed to say that the Governor is pleased to accord a revised administrative approval of the above mentioned project at an estimated cost of Rs. 43.38 Lakh under ARWSP during 2009-10.

2. All other conditions as enumerated in the previous order will remain unchanged.
3. The undersigned is also directed to sanction and allocate further an amount of Rs. 22.91 lakh (Rupees twenty two lakh and ninety one thousand) only and place the same at the disposal of the Chief Engineer(Head Quarters), PHE Directorate, West Bengal for the purpose mentioned here in above. The Chief Engineer (Head Quarters), PHE Directorate, West Bengal is requested to release the fund to the concerned Executive Engineer only on the basis of LOC to be issued with the concurrence of the Finance Department .
4. The charge is debitible to the head of account, " 4215-01-102-CS-002-53" under Demand No.45[PH] during the current financial year.
5. Utilization certificate for the present sanction may be submitted in due course of time .
6. This Order of this revised administrative approval issues with the concurrence of the Finance Department Group-F, U.O.No.451 dated, 18.11.09. Allocation of fund has been made in exercise of the powers delegated under Finance Department memo no. 902- F.B. dated, 27.07.2009.
7. The Principal Accountant General(West Bengal) and Kolkata Pay and Accounts Officer are being informed.
