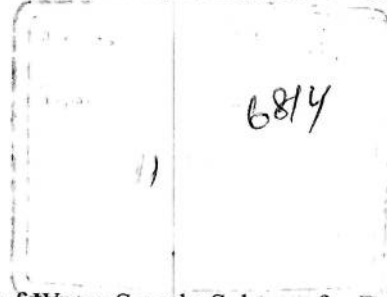

Subject:- Administrative approval of Water Supply Scheme for Daronda and adjoining mouzas at Illambazar Block of Birbhum District under NRDWP during 2010-2011.

ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval towards the implementation of Ground Water Based Water Supply Scheme for Daronda and adjoining mouzas at Illambazar Block of Birbhum District at a total estimated cost of Rs.338.12 lakh under NRDWP(Coverage) during the current financial year.

2. The administrative approval accorded herein is also subject to the conditions that:-
- Contingency cost has been restricted to 2%.
 - Strict observance of the usual rules and procedure.
 - Non-overlapping of the schemes with any other water supply schemes.
 - The projects are to be completed within the stipulated period of three years.
 - No new post is to be created for operation and maintenance of the schemes at a future date
 - Committee for house to house connection shall be constituted as soon as the scheme is completed and ;
 - The process for handing over the distribution system of the Scheme to the concerned Gram Panchayat shall be initiated as soon as the Scheme is implemented and keep this Department informed after completion of the process.
3. This Order issues with the concurrence of the Finance Department Group-F, U.O.No.36 dated,20.05.2010.
4. The necessary allotment of fund will be made from Central Share of the Programme fund of SWSM Account.
