ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval for implementation of 2 (two) nos. of schemes in the Districts of Darjeeling & Cooch Behar as noted in the Table below at an estimated cost of **Rs. 389.62 lakh** (Rupees three hundred eighty nine lakh and sixty two thousand) only during the year 2008-09. - Contingency cost has been restricted to 2% ;
 - Strict observance of the usual rules and procedure ;
 - Non-overlapping of the schemes with any other water supply schemes ;
 - The project is to be completed within the stipulated period of three years ;
 - No new post is to be created for operation and maintenance of the schemes at a future date;
 - 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;
