The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval of the following Schemes for-repairing and renovation work at Sinchal range , Darjeeling under ARWSP at a total estimated cost of Rs.47.99 lakhs(Rupees forty seven lakh and ninety nine thousand)only and for procurement of three nos. of new Rig Machines at a total estimated cost of Rs.436.31 lakh(Rupees four crore thirty six lakh and thirty one thousand) only under ARWSP and State Plan on 50:50 Share during this financial year.

The undersigned is also directed to sanction and allocate an amount of Rs.47.99lakhs(Rupees forty seven lakh and ninty nine thousand) only for implementation of the Scheme as mentioned in Serial no 1. and place the same at the disposal of the Chief Engineer(Head Quarters), PHE Directorate, West Bengal for execution of the Scheme mentioned here in nbovc . The Chief Engineer (Head Quarters), PHE Directorate, West Bengal is requested to release the fund to the concerned Executive Engineer only on the basis of LOC to be issued with the concurrence of the Finance Department .
3. The charge is debitabale to the head of account, " 4215-01-102-CS-002-53" under Demand No.45[PH] during the current financial year.
4. Utilization certificate for the present sanction may be submitted in due time so that Finance Department could be moved for further release of fund .
5. The administrative approval accorded herein is also subject to the conditions that:-
 - a. Contingency cost has been restricted to 2%;
 - b. Strict observance of the usual rules and procedure;
 - c. Non-overlapping of the schemes with any other schemes.
 - d. The project is to be completed within the stipulated period and Procurement of Rig Machines should be completed within this financial year.
 - e. No new post is to be created for operation and maintenance of the schemes at a future date.
6. This Order issues with the concurrence of the Finance Department Group-P, U.O.No. mentioned against each of the schemes.
7. The Sabhadhipati of Siliguri Mahakuma Parishad (Darjeeling) may be kept informed of the administrative approval of the schemes and the allotment thereof.
8. The Principal Accountant General(West Bengal) and Kolkata Pay and Accounts Officer are being informed.
