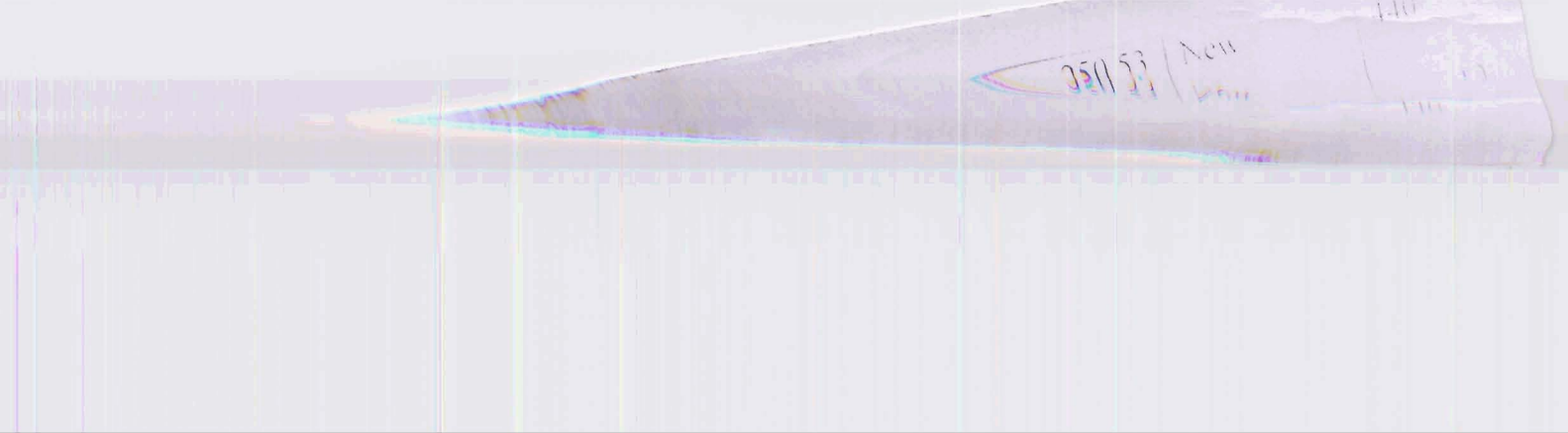

2. The administrative approval accorded herein is also subject to the conditions that :-
- Contingency cost has been restricted to 2% ;
 - Strict observance of the usual rules and procedure ;
 - Non-overlapping of the schemes with any other water supply schemes ;
 - The project is to be completed within the stipulated period of three years ;
 - No new post is to be created for operation and maintenance of the schemes at a future date;
 - 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;
3. This order issues with the concurrence of the Finance Department (Group-F), U.O. Nos. & dates shown in the Table against each scheme.
4. The Sabhadhipaties, of concerned Zilla Parishads may be kept informed of the administrative approval for the said schemes.
