2. The undersigned has also been directed to sanction and allocate an amount of Rs. 232.17 lakh (rupees two hundred thirty two lakh seventeen thousand) only and place the same at the disposal of the Chief Engineer, Mechanical/ Electrical, PHE Directorate, West Bengal for execution of the 4 (four) schemes mentioned here in above. The Chief Engineer, Mechanical/ Electrical, PHE Directorate West Bengal is requested to release the fund to the concerned Executive Engineers only on the basis of LOC to be issued with the concurrence of the Finance Department.

3. The charge in respect of the State Plan is debitable to the following heads of account out of 'On Account' budget provision under Demand No 45 [PH] during the current financial year:—

4. Utilisation Certificate for the present sanction may be submitted in due time so that Finance Department could be moved for further release of fund.


5. The administrative approval accorded herein is also subject to the conditions that :—

- a) Contingency cost has been restricted to 2%;
- b) Strict observance of usual rules and procedures;
- c) Non-overlapping of the schemes with any other water supply schemes;
- d) The projects are to be completed within the stipulated period of two years;
- e) No new posts are to be created for Operation and Maintenance of the schemes at a future date;
- f) Arrangement may be made for handing over of Distribution System to the concerned G.P. as soon as the scheme is completed.

6. This Order issues with the concurrence of the Finance Department Group "F" U.O. No. mentioned against each of the schemes. Allocation of fund have been made in exercise of the powers delegated by the Finance Department memo no.2320-F.B. dt.31.03.2008.

7. The Sabhadhipaties of the concerned Zilla Parishads may be kept informed of the administrative approval of the schemes and allotment thereof.

8. The Principal Accountant General (West Bengal) and the Kolkata Pay and Accounts Officer are being informed.
