2. The undersigned is also directed to sanction and allocate an amount of Rs. Rs.237.77 lakhs (Rupees Two crore thirty seven lakh and seventy seven thousand)only and place the same at the disposal of the Chief Engineer(Head Quarters), PHE Directorate, West Bengal for execution of the Schemes mentioned here in above . The Chief Engineer (Head Quarters), PHE Directorate, West Bengal is requested to release the fund to the concerned Executive Engineers only on the basis of LOC to be issued with the concurrence of the Finance Department .
3. The charge is debitible to the following heads of account as per following break-up:-
a. 4215-01-800-SP-002-53 = Rs. 155.00 Lakh
b. 4215-01-789-SP-003-53 = Rs. 59.44 Lakh.
b. 4215-01-800-SP-004-53 = Rs. 23.33 Lakh
Total = Rs. 237.77 Lakh
under Demand No.45[PH] during the current financial year.
4. Utilisation certificate for the present sanction may be submitted in due time so that Finance Department could be moved for further release of fund .
5. The administrative approval accorded herein is also subject to the conditions that:-
a. Contingency cost has been restricted to 2%.;
b. Strict observance of the usual rules and procedure;
c. Non-overlapping of the schemes with any other water supply schemes.
d. The projects are to be completed within the stipulated period of two years and
e. No new post is to be created for operation and maintenance of the schemes at a future date.
f. Committee for house to house connection shall be constituted as soon as the scheme is completed.
6. This Order issues with the concurrence of the Finance Department Group-F, U.O.No. mentioned against each of the schemes. Allocation of fund has been made in exercise of the powers delegated under Finance Department memo no. 1818-F.B., dt 31.12.2008.
7. The Sabhadhipatis of concerned Zilla Parishads may be kept informed of the administrative approval of the schemes and the allotment thereof.
8. The Principal Accountant General(West Bengal) and Kolkata Pay and Accounts Officer are being informed.
