Sub. : Administrative approval for Benipur Ground Water Based W/S
Scheme at Bhagawangola-II Block in the District of Murshidabad
under Water Quality Sub-Mission during the year 2009-10.

The undersigned is directed to say that the Governor is pleased to accord administrative approval at a total estimated cost of **Rs. 362.96 Lakh** (Rupees three hundred sixty two lakh and ninety six thousand) only for Benipur Ground Water Based W/S Scheme at Bhagawangola-II Block in the District of Murshidabad under Water Quality Sub-Mission during the year 2009-10. The funding pattern of the said scheme is as follows :-

A) GOI's Share of Water Quality Sub-Mission	=	Rs. 210.13 lakh.
B) State Share	=	Rs. 70.04 lakh.
C) ARWSP	=	Rs. 70.04 lakh.
D) Community Contribution	=	Rs. 12.75 lakh.
Total	=	Rs. 362.96 lakh.

2. The administrative approval accorded herein is also subject to the conditions that :-
 - a. Contingency cost has been restricted to 2% ;
 - b. Strict observance of the usual rules and procedure ;
 - c. Non-overlapping of the schemes with any other water supply schemes ;
 - d. The project is to be completed within the stipulated period of three years ;
 - e. No new post is to be created for operation and maintenance of the schemes at a future date;
 - f. 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;
3. This order issues with the concurrence of the Finance Department (Group-F), U.O. No. 1005, Dt. 13/03/09.
4. The Sabhadhipati of Murshidabad Zila Parishad may be kept informed of the administrative approval for the said scheme.
5. The Principal Accountant General, West Bengal and Pay & Accounts Officer, Kolkata are being informed.
