Bhagabati Rural Piped Water Supply scheme under ARWSP
during 2008-09

ORDER

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord administrative approval to the implementation of Bhagabati Rural Piped Water Supply scheme in the District of Uttar Dinajpur under ARWSP at a total estimated cost of Rs. 391.29 lakh (rupees three hundred ninety one lakh twenty nine thousand) only during the current financial year.

2. The undersigned has also been directed to sanction and allocate an amount of Rs. 1.00 crore (rupees one crore) only and place the same at the disposal of the Chief Engineer, Head Quarters, PHE Directorate, West Bengal for execution of the scheme. The Chief Engineer, Head Quarters, PHE Directorate West Bengal is requested to release the fund to the concerned Executive Engineer only on the basis of LOC to be issued with the concurrence of the Finance Department.

3. The charge is debit to the following head of account under Demand No 45 [PH] during the current financial year:—

4215-01-102-CS-002-53 = Rs. 1.00 crore

4. Utilisation Certificate for the present sanction may be submitted in due time so that Finance Department could be moved for further release of fund.

5. The administrative approval accorded herein is also subject to the conditions that :—

- g) Contingency cost has been restricted to 2%;
- h) Strict observance of usual rules and procedures;
- i) Non-overlapping of the schemes with any other water supply schemes;
- j) The projects are to be completed within the stipulated period of two years;
- k) No new posts are to be created for Operation and Maintenance of the schemes at a future date;
- l) Arrangement may be made for handing over of Distribution System to the concerned G.P. as soon as the scheme is completed.

6. This Order issues with the concurrence of the Finance Department Group "F" U.O. No.143 dt.21.08.2008. Allocation of fund have been made in exercise of the powers delegated by the Finance Department memo no.852-F.B. dt. 31.07.2008.

7. The Sabhadhipati, Uttar Dinajpur Zilla Parishad may be kept informed of the administrative approval of the scheme and allotment thereof.

8. The Principal Accountant General (West Bengal) and the Kolkata Pay and Accounts Officer are being informed.
