W/S Scheme at Chakdah Block in the District of Nadia  
under Water Quality Sub-Mission during the year 2008-09.

The undersigned is directed to say that the Governor is pleased to accord administrative approval at a total estimated cost of **Rs. 1385.00 Lakh** (Rupees eleven thousand three hundred eighty four lakh) only for Chakdah Surface Water Based W/S Scheme at Chakdah Block in the District of Nadia under Water Quality Sub-Mission during the year 2008-09. The funding pattern of the said scheme is as follows :-

A) GO's Share of Water Quality Sub-Mission	=	Rs. 8046.37 lakh.
B) State Share	=	Rs. 2682.12 lakh.
C) Community Contribution	=	Rs. 194.81 lakh.
D) State Share (Urban Part)	=	Rs. 461.70 lakh.
Total	=	Rs. 11385.00 lakh.

2. The administrative approval accorded herein is also subject to the conditions that :-

- a. Contingency cost has been restricted to 2% ;
- b. Strict observance of the usual rules and procedure ;
- c. Non-overlapping of the schemes with any other water supply schemes ;
- d. The project is to be completed within the stipulated period of three years ;
- e. No new post is to be created for operation and maintenance of the schemes at a future date;
- f. 100% O & M cost of the scheme shall have to be borne by the PRL/Beneficiary;
