**Sub.** : Administrative approval for Haringhata Surface Water Based  
W/S Scheme at Haringhata Block in the District of Nadia  
under Water Quality Sub-Mission during the year 2008-09.

The undersigned is directed to say that the Governor is pleased to accord administrative approval at a total estimated cost of **Rs. 10739.00 Lakh** (Rupees ten thousand seven hundred thirty nine lakh ) only Haringhata Surface Water Based W/S Scheme at Haringhata Block in the District of Nadia under Water Quality Sub-Mission during the year 2008-09. The funding pattern of the said scheme is as follows :-

A) GOI's Share of Water Quality Sub-Mission	=	Rs. 7293.65 lakh.
B) State Share	=	Rs. 2431.22 lakh.
C) ARWSP (Non-Quality)	-	Rs. 252.20 lakh.
D) Community Contribution	-	Rs. 282.88 lakh.
E) State Share (Urban Part)	-	Rs. 480.05 lakh
Total	-	Rs. 10739.00 lakh.

- The administrative approval accorded herein is also subject to the conditions that :-
  - Contingency cost has been restricted to 2% ;
  - Strict observance of the usual rules and procedure ;
  - Non-overlapping of the schemes with any other water supply schemes ;
  - The project is to be completed within the stipulated period of three years ;
  - No new post is to be created for operation and maintenance of the schemes at a future date ;
  - 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary ;

- The Sabhadhipati of Nadia Zila Parishad may be kept informed of the administrative approval for the said scheme.
