ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval for implementation of Ground Water Based Piped Water Supply Scheme for Naserkuli & adjoining mouzas under Ranaghat-II Block in the district of Nadia at a total estimated cost of **Rs. 971.73 lakh** (Rupees nine hundred and seventy one lakh and seventy three thousand) only during the year 2008-09. The Funding Pattern in respect of the said scheme is as follows:-


A) GOI's Share of Water Quality Sub-Mission	:	Rs. 549.80 lakh
B) State Share	:	Rs. 183.27 lakh
C) ARWSP (Non- Quality affected habitation)	:	Rs. 201.86 lakh
D) Community Contribution	:	Rs. 36.80 lakh
Total	=	Rs. 971.73 lakh

2. The administrative approval accorded herein is also subject to the conditions that:-
- Contingency cost has been restricted to 2% ;
 - Strict observance of the usual rules and procedure ;
 - Non-overlapping of the schemes with any other water **supply** schemes :
 - The project is to be completed within the stipulated period of three years ;
 - No new post is to be created for operation and maintenance of the schemes at a future date
 - 100% O & M cost of the scheme shall have to be borne by the PRD/Beneficiary
