Sub. : Administrative approval for Paharpur Ground Water Based
W/S Scheme at Ratua -II Block in the District of Malda
under Water Quality Sub-Mission during the year 2008-09.

The undersigned is directed to say that the Governor is pleased to accord administrative approval at a total estimated cost of **Rs. 194.09 Lakh** (Rupees one hundred ninety four lakh and nine thousand) only Paharpur Ground Water Based W/S Scheme at Ratua -II Block in the District of Malda under Water Quality Sub-Mission during the year 2008-09. The funding pattern of the said scheme is as follows :-

A) GOI's Share of Water Quality Sub-Mission	=	Rs. 118.54 lakh.
B) State Share	=	Rs. 39.51 lakh.
C) ARWSP	=	Rs. 31.61 lakh.
D) Community Contribution	=	Rs. 4.43 lakh.
Total	=	Rs. 194.09 lakh.

2. The administrative approval accorded herein is also subject to the conditions that :-
- Contingency cost has been restricted to 2% ;
 - Strict observance of the usual rules and procedure ;
 - Non-overlapping of the schemes with any other water supply schemes ;
 - The project is to be completed within the stipulated period of three years ;
 - No new post is to be created for operation and maintenance of the schemes at a future date;
 - 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;
3. This order issues with the concurrence of the Finance Department (Group-F), U.O. No. 1005, Dt. 13/03/09.
4. The Sabhadhipati of Malda Zila Parishad may be kept informed of the administrative approval for the said scheme.
5. The Principal Accountant General, West Bengal and Pay & Accounts Officer, Kolkata are being informed.
