Sub. : Administrative Approval for Ground Water-Based Piped Water Supply Scheme under Water Quality Sub-Mission for Paltadanga & Adjoining Mouzas at Barasat-II Block in the district of North 24-Parganas during 2008-09

**ORDER**

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval for implementation of Paltadanga Water Supply Scheme under Water Quality Sub-Mission at Barasat-II Block in the District of North 24-Parganas at a total estimated cost of **Rs.358.73 lakh** (Rupees Three Hundred Fifty Eight Lakh and Seventy Three Thousand) only during the year 2008-09. The Funding Pattern in respect of the said scheme is as follows:-

A) GOI's Share of Water Quality Sub-Mission	: Rs. 143.53 lakh
B) State Share	: Rs. 47.84 lakh
C) ARWSP (Non-Quality)	: Rs. 153.10 lakh
D) Community Contribution	: Rs. 14.26 lakh
Total	= Rs. 358.73 lakh

2. The administrative approval accorded herein is also subject to the conditions that :-

- Contingency cost has been restricted to 2% ;
- Strict observance of the usual rules and procedure ;
- Non-overlapping of the schemes with any other water supply schemes ;
- The project is to be completed within the stipulated period of three years ;
- No new post is to be created for operation and maintenance of the schemes at a future date;
- 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;

3. This order issues with the concurrence of the Finance Department (Group-F), U O. No 126, Dt 17-07-08.

4. The Sabhadhipati, of concerned Zilla Parishad may be kept informed of the administrative approval for the said scheme.

5. The Accountant General, West Bengal and Kolkata Pay & Accounts Officer are being informed.
