Sub : Administrative Approval for Ground Water Based Piped Water Supply Scheme under Water Quality Sub-Mission for Teghari & adjoining mouzas at Raghunathganj -II Block in the district of Murshidabad during 2008-09.

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval for implementation of Kasiadanga Water Supply Scheme under Water Quality Sub-Mission at Raghunathganj -II Block in the district of Murshidabad at a total estimated cost of **Rs.407.45 lakh** (Rupees four hundred seven lakh & forty five thousand) only during the year 2008-09. The Funding **Pattern** in respect of the said scheme is as follows :-

A) Col's Share of Water Quality Sub-Mission	:	Rs. 298.49 lakh
B) State Share	:	Ks. 99.50 lakh
C) ARWSP	:	Nil
D) Community Contribution	:	Rs. 9.46 lakh

Total = : Ks. 407.45 lakh

2. The administrative approval accorded herein is also subject to the conditions that :-
 - a. Contingency cos has **been** restricted to 2% ;
 - b. Strict observance of the **usual** rules and procedure ;
 - c. Non-overlapping of the schemes with any other water **supply** schemes ;
 - d. The project is to be completed within the stipulated period of three years ;
 - e. No new post is to be created **for** operation and maintenance of the schemes at a future date;
 - f. 100% O & M cost of the scheme shall have to be borne by the PRI/Beneficiary;
3. This order issues with the concurrence of the Finance Department (Group-F), U.O. No. 643 Dt. 06.02.09.
4. The Sabhadhipati, of Murshidabad Zilla Parishad may be kept informed of the administrative approval **for** the **said** scheme.
